- The candidate who desires to apply for more than one Non-Teaching/Administrative post will be required to apply separate application and an additional application fee along with each application.
- 2. The appointment of the selected candidate for the said post on regular basis from the grants released by state government shall be subject to the conditions laid down by the state government / university from time to time. Recruitment of Non-teaching/Administrative post as mentioned shall be as per Resolution No. KhRCh/2002/57/(Part-4)/z.1, Dated 18-10-2023 of Finance Department, Government of Gujarat on fix pay for the first five years.
- Applicants must submit the application through online recruitment portal at <a href="https://vnsgunt.samarth.edu.in">https://vnsgunt.samarth.edu.in</a>. on or before dt. 21/11/2025 till 6:00 pm and must upload the necessary documents with the online application.
- 4. Applicant shall submit copy of printout of the application along with necessary certificates and testimonial in two sets by Speed Post/Registered Ad/In person to The Registrar, Veer Narmad South Gujarat University, University Campus, Udhna- Magdalla Road, Surat-395007. The envelope should be superscripted with "Application for the post of ............." so as to reach The Registrar, Veer Narmad South Gujarat University, University Campus, Udhna- Magdalla Road, Surat-395007 on or before dt. 28/11/2025 till 6:10 pm. Applications received after the due date will not be considered. The University will not be responsible for postal delay, if any.
- 5. The applicant must ensure that he/she fulfills the eligibility conditions for the Post applied as per respective Notifications.
- 6. In no circumstances any content of the application form should be modified.
- 7. The prescribed application fee is Rs.500 /- (Five Hundred only) for General Category and 200/- (Two Hundred only) for Scheduled Caste (SC)/ Scheduled Tribe (ST)/ Socially and Economically Backward Class (SEBC)/ Economically Weaker Section (EWS) to be payable online.
- 8. Bank charges towards the online payment service as applicable will be additionally payable by the candidate.
- 9. Reservation for SC/ST/SEBC/EWS and Persons with Benchmark Disabilities will be as per the existing policy of Government of Gujarat.
- 10. Candidates belonging to reserved category (SC/ST/SEBC/EWS) or physically handicapped or Exserviceman must attach necessary certificate from the competent authority of the state. SEBC candidate should furnish the Current Financial Year's "Non-Creamy Layer Certificate" in the prescribed Performa along with his/her application form, failing which the candidate will not be

- entitled to get the benefit of reserved category. SC, ST, SEBC and EWS candidates of origin of Gujarat can only avail the benefit of reservation.
- 11. Candidates seeking reservation under Scheduled Caste (SC)/ Scheduled Tribe (ST) Category are required to submit Certificate in the format prescribed by the Government of Gujarat.
- 12. Candidates applying for the Post (s) reserved for socially and Economically Backward Class (SEBC) should submit a Self-Attested Copy of a Valid Caste Certificate specifically mentioning Creamy Layer-Exclusion in the format prescribed by the Government of Gujarat.
- 13. Candidates applying for the Post (s) reserved for EWS Category have to submit Certificates for eligibility for reservation in favour of EWS in the format as prescribed by the Government of Gujarat.
